On the first and third Monday of each month, the Dare County Board of Commissioners meets at the Dare County Administrative Annex in Manteo. Groundbreaking RI Senior/Community Center

Those responsible for planning the center gather with others from the public to break ground on the property where the center will be built. Speakers include Warren Judge, Chairman DCBC, Virginia Tillett, Commissioner, and others involved in the planning.

Negotiated Rulemaking Friday Nov. 14, Morning Session

A meeting of the Negotiated Rulemaking Committee for Cape Hatteras National Seashore Recreational Area. This session includes the welcome by Mike Murray, NPS; review of objectives; brief updates, including NEPA process and Socio-Economic Study; a presentation on Sea Turtles; and a public comment period with specific comments requested on turtle management.

Negotiated Rulemaking Friday Nov. 14, Afternoon Session

A meeting of the Negotiated Rulemaking Committee for Cape Hatteras National Seashore Recreational Area. This session includes an NPS overview of Draft Environmental Impact Statement (DEIS) alternatives; small group report outs on their discussions of implications of DEIS alternatives; and an additional public comment period with comments requested on what is promising in the NPS DEIS alternatives and how might the committee use, combine or improve them to build a committee preferred alternative.

Negotiated Rulemaking Saturday Nov. 15, Morning Session

A meeting of the Negotiated Rulemaking Committee for Cape Hatteras National Seashore Recreational Area. This session includes reflections on Day 1; NPS proposed approach to safety closures; subcommittee reports; and public comment with comments requested on NPS DEIS alternatives.

Negotiated Rulemaking Saturday Nov. 15, Afternoon Session

A meeting of the Negotiated Rulemaking Committee for Cape Hatteras National Seashore Recreational Area. This session includes planning for future meetings, agenda for December meeting; approval of September meeting summary; and summary and closing remarks.
